

Grove Park Pool Rules

Hours: 9:00am to 8:00pm

By the order of the Cobb County Health Department and Grove Park documents all residents and guests must follow the pool rules. It is a family friendly swimming pool for all residents and not for residents own private use. If a violation is cited, it may cause the pool to close for an extended period and/or result in loss of swimming privileges.

THE FOLLOWING RULES AND REGULATIONS MUST BE FOLLOWED:

1. The Grove Park Community Pool is a non-smoking and non-alcoholic facility – including and not limited to E-cigs/Vaping, tobacco, beer, wine, and liquor. This applies anywhere inside the gated pool area and within 25 ft. of the pool fence/gate. This includes the bathrooms.
2. According to Cobb County Code, the pool access gate may not be propped open at any time by any resident or guest. It violates health and safety regulations for Cobb County. Cobb County can close the pool and fine for infractions.
3. FOBS ARE NOT TO BE SHARED AT ANY TIME. Each fob is specifically assigned to the homeowner. Allowing others to use your assigned fob is a violation of pool rules and will result in loss of swimming privileges and fines.
4. Guests must always be accompanied by a current homeowner or legal renter. The homeowner/legal renter is responsible for the conduct of their guests. THERE IS A MAXIMUM OF FOUR GUESTS PER HOMEOWNER.
5. Children under the age of 16 must be accompanied by their legal guardian. Legal guardians must always remain with any child under the age of 16. Children under the age of 16 may not be dropped off and left at the pool under ANY CIRCUMSTANCE.
6. Parties or special events are strictly prohibited.
7. Pets are not allowed on the premises.
8. Proper swim attire is required in the pool. No cutoffs or street clothes.
9. Training pants with snug fitting rubber pants or swim diapers are required for any infant/child not toilet trained prior to entering the pool area or fenced-in pool deck. Fecal contamination will cause the pool to close. The association reserves the right to charge owners responsible for the cost of treatment.
10. A legal guardian must always remain in the pool with diapered children.
11. No glass containers are allowed in the pool or deck area. Broken glass may cause the pool to close. The homeowner will incur the costs associated with draining and re-filling of the pool.
12. Diving or entering the pool head-first is strictly prohibited.
13. When the pool closes at 8:00pm, all residents and their guests must leave the pool area.
14. Refrain from using the pool if you have open wounds, sores, or lesions and if you have had a fever, diarrhea, or vomiting in the last 48 hrs.
15. Do not swim if suction outlets are missing, broken or not visible.
16. Music must not be played aloud. Ear buds are permissible for your own music.
17. Only certified floating pool toys are allowed in the pool. No basketballs, footballs, or small toys that can clog the filtering system.
18. Running, rough housing, disrespectful behavior, and obscene language are strictly forbidden in the pool area.
19. No eating in the pool or on the pool deck. Use the picnic tables under the pavilion.
20. No one is allowed in the office or pump room unless they have permission from the HOA board.
21. Above rules will be enforced by the HOA Board approved pool attendant. Any violation of these rules will be reported to the HOA board/CMA and action will be taken immediately.

IN CASE OF EMERGENCY USE THE EMERGENCY PHONE – IT IS LOCATED IN THE PAVILION. IT WILL AUTOMATICALLY CONNECT TO ACWORTH POLICE.
